

Instructions for Completing the 2009-2010 Federal PLUS Loan Data Form

1. Select a lender. By choosing a lender which participates in Electronic Funds Transfer (EFT), the processing and disbursement of your loan will be expedited. For other EFT lenders not listed on this form please go to Step 1 Section B in the online application. When choosing a lender not listed please complete and submit the Lender Information Sheet available in our online application in Step 1 Section C and an originally signed Stafford Master Promissory Note. **Remember, GW will certify any properly completed loan application for students wishing to select a lender not listed on this form, just be sure to follow the steps above.**

2. Indicate the requested loan amount. You must specify an actual dollar amount. You are eligible to apply for up to the Cost of Attendance at GW minus any other aid the student will be receiving either from the university or any other agency.

3. We will process the Federal Stafford Loan before we process the Federal PLUS Loan because the terms of the Federal Stafford Loan are more advantageous. It is the student's responsibility to ensure that we have all proper documentation to complete the Federal Stafford Loan certification process.

4. When completing the Federal PLUS Master Promissory Note (PLUS MPN), please be sure to complete every item and initial any changes/corrections. Failure to properly complete the Federal PLUS MPN will result in processing delays.

The processing of aid for students enrolled in a distance education (DE) program is based on current federal regulations. The cost of attendance component for DE students includes tuition, fees, books and supplies (living expenses are not included.) A student enrolled in any of the DE programs is not eligible for University grants and/or scholarships.
